Welcome to the Kennel Club Litter Registration Service. We would like to thank you in advance for registering your litter with the Kennel Club. By doing so you will be helping to safeguard your puppies future.

We kindly urge you to complete this form as early as possible to ensure that the relevant registration documents are available for the new owners at the time of sale/collection. Please read carefully the relevant section notes contained within the guide before filling in the form.

Please note, failure to fully complete the application form and/or include the correct payment will delay the registration process. Please refer to the guide notes and the check list to help you through this process.

KENNEL NAME

A Kennel Name is effectively a "brand" name and it will differentiate your puppies from those of anyone else who registers puppies within your breed(s). The Kennel Club will protect this word for your sole use for an initial charge and annual fee. This Exclusive Breeder Signature also provides you with access to a hotline, where you will receive 'fast-track' access to all registration services. If you do not have a Kennel Name then it is not too late to apply - you could even use it on the puppies you are about to register. As well as being able to use your Exclusive Breeder Signature on puppy registrations, you can also add this word onto the names of dogs which are already registered in your ownership. To find out more, simply call us on 0870 241 7305.

Additionally, as a Kennel Name holder you will also benefit from a complimentary naming service (see details below). The additional fee is not chargeable for use of this service if you have a Kennel Name and are using this as a prefix on all of your puppies names.

ONLINE LITTER REGISTRATION

The Kennel Club has launched a new service for Breeders to register their litters online. The first phase is the release of a pilot system which is currently only available to Kennel Name holders. To find out more visit www.the-kennel-club.org.uk or call us on 0870 950 6790.

PUPPY NAMING SERVICE

Approximately one in every 10 litter applications does not have the puppies names included and the Kennel Club staff are asked to create them on the breeder's behalf. This is a highly skilled task which takes many months training and adds a great deal of time to the registration process. Therefore, a charge is made for this service and the Kennel Club staff will create names for puppies at a charge of £20. The charge will cover the whole litter and will be in addition to the normal registration fee. This service is free for Kennel Name holders.

Note: Please note that any objection to a name registered using this service must be made in writing within one month of the registration date. However, the Kennel Club has no obligation to change a name it has selected when requested, where all reasonable and relevant attempts has been made to carefully select a suitable name on behalf of the Breeder.

PUPPY SALES REGISTER

Over 10,500 breeders have used the Puppy Sales Register in the past 12 months to help find suitable homes for their puppies. For just £15 the details of your litter will be issued on a printed list and on the Kennel Club website for a period of two calendar months.

Over one and a half million searches for breeders details were carried out by potential puppy owners in the past 12 months for details of breeders. The Puppy Sales Register provides potential dog owners with a list of Kennel Club Registered puppies, by breed. It also includes essential information on responsible pet ownership and advice to potential owners on choosing the right dog for their lifestyle.

A guide to help you complete the litter registration form

This form should be used by the breeder to register, by name, all puppies in a litter under 12 months of age (see notes*). It should be completed in **BLOCK CAPITALS** in **black ink** throughout and sent to the Kennel Club.

1. The Registered Breeder(s) name and address

The breeder is the registered owner(s) of the dam at the date of birth of the litter (unless stipulated otherwise on an official Loan of Bitch Agreement). **The declaration must be signed by the breeder. In the case of joint ownership, all owners must sign.**

2. The Registered Stud Dog Owner(s) name and address

The owner(s) of the registered stud dog is the owner(s) at the date of mating. **The confirmation of mating must be signed by the owner(s) of the sire. In the case of joint ownership, all owners must sign. It is advisable to have this confirmation signed at the time of mating.**

3. Registered name of Dam of litter

The Kennel Club registered name and registration number of the dam should be written exactly as shown on the Kennel Club registration certificate. Please include the permanent identification number, if applicable, together with the method used.

If a bitch is served by more than one dog of the same breed as herself in the same heat, the identity of the correct sire of each puppy in the litter must be established via DNA testing in order to register the resulting progeny.

For registration purposes the dam must be resident at a UK address at the date of whelping. Please note that the term UK address includes Northern Ireland, but does not include the Republic of Ireland and the Channel Islands.

4. Registered name of Sire of litter

Complete as above - details for Dam.

If the sire is registered with an overseas Kennel Club and resident in the same country application will be accepted. However applications must include one of the following documents for the sire to be recorded by the Kennel Club together with the appropriate payment:

- A copy of the 3 generation certified pedigree issued by the overseas Kennel Club - £20
- A copy of the 5 generation certified pedigree issued by the overseas Kennel Club - £25

Please note: If the sire has previously been issued with an Authority to Compete Number, the above requirement does not apply. Please write this number in section 4 in place of the Kennel Club registration number.

7. The Breed of the dog

The Kennel Club recognised name for the breed should be included in this section.

8. Kennel Name

Breeders who have a Kennel Name should enter it in this box.

The dam must be in the identical ownership to that of the Kennel Name holder.

9. Guidelines to Naming Puppies (please read carefully)

- a A name must consist of more than one word but not exceed 24 letters.
- b A name which conflicts with an approved current Kennel Name granted to another person will not be accepted.
- c The surname of the applicant is not acceptable.
- d A word cannot be repeated when naming puppies, unless an application is made to register the word as a Kennel Name. However, the repetition of a single common word may be allowed in the centre or end of the name, providing it cannot be mistaken for a registered Kennel Name.
- e If a Kennel Name is to be used when registering a litter, the Kennel Name must appear as the first word in the name. The Kennel Club will not allow the use of a registered Kennel Name (exactly as it is spelt/granted) in any puppy's name, unless the applicant is the registered Kennel Name holder.
- f A Kennel Name holder is entitled to repeat their granted word in each puppy's name (as a prefix).
- g Initials cannot be used and abbreviations may be disallowed.
- h Numbers in figures are not acceptable. Numbers in words are acceptable except when used to indicate a sequence, e.g. "Morris Dancer the Second".
- i Punctuation marks may be disallowed.

The Code of Ethics is printed in the Guide to Litter Registration booklet and on the Kennel Club website; www.the-kennel-club.org.uk. The Kennel Club Rules and Regulations are contained in the Kennel Club Year Book which can be obtained from the Kennel Club on 0870 606 6750.

- j Canine terms are not permissible, e.g. "dog", "bitch", "Kennel", "Champion", "Crufts" and specific names of breeds.
- k It is not advisable to use words from a dog's pedigree. These may include Kennel Name (and therefore will not be acceptable).
- l The Kennel Club reserves the right to refuse any name, which it considers inappropriate or offensive. The Kennel Club also retains the right to request a fresh name for any puppy after the registration has been accepted, in the event of a complaint being lodged with the Kennel Club which is upheld.
- m Once registered, a name may not be repeated.
- n The Kennel Club reserves the right to impose a Puppy Naming Service Fee when the above guidelines are not met.

Endorsements

The registered owner(s) of a dog may, **whilst the dog is still in his/her physical possession**, apply to have any or all of the following endorsements placed on the records of the dog:

Code	Item
R	Progeny not eligible for registration
X	Not eligible for the issue of an Export Pedigree

These codes should be included next to the relevant puppy if the breeder wishes to place any endorsements.

Breeders wishing to endorse any puppies should make themselves fully aware of the **complete** regulation contained in the Kennel Club Year Book relating to the use of endorsements, including the need to obtain written and signed confirmation that the prospective new owner is aware of the endorsement(s).

A research fee of £12 per hour plus VAT may be charged to complete a pedigree for dogs over 5 years old or imported.

Non acceptance of registration

The Kennel Club will not accept an application to register a litter when:

- a) The dam has already whelped six litters, or
- b) The dam has already reached the age of eight years at the date of whelping
- c) The dam was under 12 months at the date of mating
- d) The dam was not resident at a UK address at the date of whelping. Please note the term UK address includes Northern Ireland. This does not expand to include the Republic of Ireland and the Channel Islands, therefore also bitches registered with the Irish Kennel Club (IKC), the Guernsey Dog Club (GDC) or the Jersey Dog Club (JDC) who are still resident within these clubs jurisdiction.

Relief from the restrictions set out in b) above may be considered by the General Committee, as per Kennel Club regulations.

NOTES: The Committee reserves the right to reject any application to register a Kennel Name or transfer any dog or to change or cancel or suspend any registration and may cancel or suspend any registration or transfer or grant of a Kennel Name already made.

The acceptance of a registration is not a guarantee of its accuracy.

When submitted, this form remains the property of the Kennel Club.

*The Kennel Club may consider late registration by the breeder of dogs over the age of 12 months, or if adding a puppy to a existing litter already requested subject to a fee of £60.00 per dog.
